PROBABLE CAUSE

CAD INCIDENT DISPOSITION CODE: [61-0] [TC] [2-1] [0]

WHILE ON ROUTINE PATROL SOUTH BOUND ON THE OVERSEAS HWY AT THE 26 MM, I WITNESSED THE SUBJECT'S (MR. MUZAFFAR) VEHICLE TRAVELING NORTH BOUND ON OVERSEAS HWY AT A HIGH RATE OF SPEED, APPROXIMATELY 90 MPH IN A 45 MPH ZONE.

I THEN WITNESSED MR. MUZAFFAR IMPROPERLY PASS TWO VEHICLES AT A CURVE IN THE ROADWAY (26.2 MM) THAT IS CLEARLY MARKED WITH DOUBLE YELLOW LINES AS A "NO PASSING AREA". MR. MUZAFFAR IMPROPERLY PASSED THREE MORE VEHICLES AT THE 28 MM IN VIOLATION OF THE TRAFFIC CONTROL DEVICE THAT IS CLEARLY MARKED ON THE ROADWAY. MR. MUZAFFAR IMPROPERLY PASSED AGAIN WITH ON COMING TRAFFIC AT THE 29 MM ON THE OVERSEAS HWY, CAUSING A VEHICLE TO PULL OFF THE ROADWAY TO AVOID A HEAD ON COLLISION. MR. MUZAFFAR MADE EACH OF THESE IMPROPER PASSING VIOLATIONS IN A EXCESS OF 100 MPH. (SPEED LIMIT FOR THIS AREA IS 45 MPH)

AT THE 30 MM NORTH BOUND ON OVERSEAS HWY, MR. MUZAFFAR FINALLY HAD TO SLOW DOWN DUE TO HEAVY TRAFFIC. I CONDUCTED A TRAFFIC STOP AT THE 30 MM. WHEN I APPROACHED MR. MUZAFFAR'S VEHICLE AND REQUESTED HIS DRIVER'S LICENSE, MR. MUZAFFAR STATED, " SORRY, JUST DRIVING BACK UP TO MIAMI". MR. MUZAFFAR'S FAMILY (THREE CHILDREN AND WIFE WERE PASSENGERS IN THE VEHICLE) MR. MUZAFFAR ALSO STATED " THIS WAS JUST A DUMB THING TO DO", " I KNOW I'M WRONG".

MR. MUZAFFAR CONTROLLED HIS VEHICLE IN A WILLFUL AND WANTON DISREGARD FOR THE SAFETY OF OTHERS. MR. MUZAFFAR WAS ARRESTED FOR RECKLESS DRIVING AND TRANSPORTED TO MONROE COUNTY JAIL, MARATHON WITHOUT INCIDENT.
