

**AFFIDAVIT IN SUPPORT OF A CRIMINAL COMPLAINT**

I, Matt Wright, having been duly sworn, depose and state the following:

1. I, Matt Wright, am presently employed by the United States Department of Homeland Security, Homeland Security Investigations (HSI) as a Special Agent. I have been employed by this agency since June 2008. I am currently assigned to the HSI New Orleans, Louisiana Cyber Crimes Unit and currently investigate individuals involved in the sexual exploitation of children.

2. I am a graduate of the Federal Law Enforcement Training Center and as a result of my training and experience as an HSI Special Agent, my duties include (but are not limited to) the investigation and enforcement of Titles 8, 18, 19, 21 and 33 of the United States Code.

3. As part of my duties as an HSI agent, I investigate criminal violations relating to the sexual exploitation of children pursuant to Title 18, United States Code, Sections 1466A, 2251, 2252, and 2252A.

**The Investigation**

4. On or about May 15, 2013, HSI New Orleans and the United States Postal Inspection Service (USPIS) executed a federal child pornography search warrant at the residence of an individual, who for the purposes of this affidavit will be identified as Administrator A, in the Eastern District of Louisiana. The investigation revealed that Administrator A enticed numerous minors, between the ages of 13 and 17, to engage in sexually explicit conduct on the Internet either alone, with other children as young as 18 months old, and animals. Administrator A recorded the sexually explicit activity and traded the material with individuals on the Internet. Administrator A also uploaded the

sexually explicit content which involved minors to two websites (Website A and Website B), which were created by Administrator A and contained child pornography.

5. Administrator A stated that he communicated with individuals involved with Website A and Website B using various computer related communication methods, including Skype, Facebook, Email, Internet Relay Chat, Team Speak, GigaTribe chat, etc. Administrator A stated that he created fake female personas, on Internet social networks, which he used to locate and entice minors to engage in sexually explicit activity for the purpose of recording the activity and for further distribution.

6. From December 1, 2012 through May 9, 2013, Aung M GAW (aka: Michael GAW) communicated with Administrator A through various forms of Internet communications, and used the following user names.

User name: "magnum.steel.2012"

User name: "roflcoptor"

During their communications, the two communicated about recording sexually explicit videos of minors on the Internet. Aung M GAW (aka: Michael GAW) stated that he had something that Administrator A would like and that he located two 14 year old teens, recorded them and the video contained "plenty of oral" sex. Aung M GAW (aka: Michael GAW) also indicated that he wanted "younger suck vids." Aung M GAW (aka: Michael GAW) and Administrator A also communicated about having "boys" engage in sexually explicit activity with dogs. The two also spoke about using various Internet social networks to locate minors, including a 14-year-old male who told Aung M GAW (aka: Michael GAW) that he would rape his 12-year-old sister. In addition, GAW and Administrator A discussed a 9-year-old female who Administrator A and Aung M

GAW (aka: Michael GAW) wanted to engage in sexually explicit activity with her brother.

7. Below are files that Administrator A sent to Aung M GAW (aka: Michael GAW).

Description: 6 minute and 50 second long video that depicted what appeared to be a 15 year old male who engaged in sexual intercourse with what appeared to be a 9 year old girl.

Video: [Name Redacted]\_skype - 14 and 12yo duo jerk, suck, 14yo cums on 12yo dick, sucks it off.avi

Received by Aung M GAW (aka: Michael GAW): 04/07/2013 at 08:02:14 AM

Description: 17 minute and 40 second long video that depicted what appeared to be a 14 year old and 12 year old male who masturbated and performed oral sex on each other's penises.

8. Information received pursuant to a Department of Homeland Security (DHS) summons response revealed that the Internet Protocol (IP) address activity, associated with a suspect Internet account, resolved to the Internet subscriber account at 39044 Sonora Ct., Fremont, CA 94538, the residence of Aung M GAW (aka: Michael GAW).

9. On November 5, 2013, a Northern District of California federal search warrant was executed at 39044 Sonora Ct., Fremont, CA 94538 to search for evidence related to the violation of Federal child pornography statutes. Aung M GAW (aka: Michael GAW) was identified as an occupant of the residence.

10. A forensic preview of Aung M GAW's (aka: Michael GAW's) computer media revealed evidence of encryption, however, agents located child pornography on a

hard drive located in GAW's bedroom. Additionally, HSI computer forensic agents located evidence of the use of the screen name "roflcopter" on GAW's computer hard drive. "Roflcopter" is known to your affiant as a screen name associated with GAW and used by GAW in communications with Administrator A during the course of their trading child pornography and their discussions regarding the sexual exploitation of children.


11. Based upon the information set forth above, there is probable cause to believe that between December 1, 2012 and May 9, 2013, in the Eastern District of Louisiana and elsewhere, Aung M GAW (aka: Michael GAW) did receive and attempt to receive child pornography, as defined by 18 U.S.C. 2256(8)(A), in violation of Title 18, United States Code, § 2252(a)(2).

12. I respectfully request that an arrest warrant be issued authorizing HSI, with the appropriate assistance from other law enforcement personnel, and/or agencies, to arrest Aung M GAW (aka: Michael GAW) for Receipt and Attempted Receipt of Child Pornography, in violation of Title 18, United States Code, § 2252(a)(2).
