STATEMENT OF PROBABLE CAUSE

THE DEFENDANT HAS BEEN ARRESTED UPON THE FOLLOWING INFORMATION OR OBSERVATION (MAKE A PLAIN, CONCISE AND DEFINITIVE STATEMENT OF ESSENTIAL FACTS CONSTITUTING THE OFFENSE CHARGE.)

On March 13, 2016 at approximately 1624 hours, uniformed patrol officers from the Prince George's County Police Department notified the Prince George's County Public Safety Communications that shots were fired at the police station by an unknown suspect. The suspect fired two rounds at the front glass door of the Prince George's County Police Department, District III Police Station shattering it. The District III Station is located at 7600 Barlowe Road Landover, Prince George's County, Maryland. The suspect also fired at passing motorists and a Prince George's County Fire/EMS ambulance driving on Barlowe Road. Noah Smith and Bryce Mendez were inside the Prince George's County Fire/EMS ambulance that was struck by the suspect's gunfire. Michael Jerome Nichols, Jr. was operating one of the vehicles that was struck by the suspect's gunfire. Officers came to the area of the front entrance of the police station to investigate. Corporal John Wynkoop #2910 took up a position at the front door and the suspect fired at him, barely missing him and other officers. The suspect then directed his fire at Officer Bryan Melius #3870, Officer Matthew Scott #4024, Corporal Jason Wells #3146, and Police Officer First Class Taylor Krauss #3556 who was responding to the scene as he entered the District III parking lot. As police officers were responding to the shooting, Detective Jacai Colson #3693 also arrived on the scene and also fired toward the suspect. Detective Colson was struck by a bullet fired by another police officer who was involved in the exchange of gunfire with the suspect. Detective Colson was transported to Prince George's County Hospital where he succumbed to his injury and was pronounced dead by Dr. Boggs.

Uniformed officers from the Prince George's County Police Department then made apprehension on the suspect who was also shot during the exchange of gunfire. The suspect was identified as MICHAEL DEANDRE FORD and he was transported by ambulance to Prince George's Hospital Center for medical treatment. The suspect's firearm was recovered at the scene of the shooting. The firearm has been identified as a Springfield Arms XP40 .40 caliber handgun.

Detectives interviewed MALIK RUSSEL FORD and ELIJAH DEION FORD and learned that MALIK RUSSEL FORD and ELIJAH DEION FORD, who are siblings of MICHAEL DEANDRE FORD, assisted and supported MICHAEL DEANDRE FORD's plan to shoot at Prince George's Police Officers at the Prince George's County District III Police Station. Both men told detectives that their brother MICHAEL DEANDRE FORD discussed with them his plan to attack the police and engage the police in a "shoot-out." MICHAEL DEANDRE FORD cycled the slide of his firearm in the presence of MALIK RUSSEL FORD AND ELIJAH DEION FORD and placed an additional magazine full of ammunition on his lap.

MALIK RUSSEL FORD and ELIJAH DEION FORD assisted by driving MICHAEL DEANDRE FORD from 1804 Ryderwood Court, Landover, Prince George's County, Maryland in a red Honda Accord to a nearby intersection, which is located at Greenleaf Road and Barlowe Road, Landover, Prince George's County, Maryland so MICHAEL DEANDRE FORD could approach the District III Station on foot. MALIK RUSSEL FORD was the driver of the red Honda Accord used to transport MICHAEL DEANDRE FORD to the area nearby the Prince George's County District III Police Station. ELIJAH DEION FORD was a passenger in the red Honda used to transport MICHAEL DEANDRE FORD and he recorded a statement from MICHAEL DEANDRE FORD during the drive from 1804 Ryderwood Court, Landover, Prince George's County, Maryland to the area of the Prince George's County District III Police Station.


All three men got out of the red Honda as MICHAEL DEANDRE FORD walked to the wrong building. The brothers directed MICHAEL DEANDRE FORD to the District III Station so he could engage the Police Officers in the planned shoot-out.

At that point, MALIK RUSSEL FORD got into the driver's seat of their vehicle and ELIJAH DEION FORD got into the front passenger seat. MALIK RUSSEL FORD and ELIJAH DEION FORD drove to a side street perpendicular to the District III Station and both remained present and ready to aid or assist MICHAEL DEANDRE FORD while both were recording the incident with their cellular telephones. MICHAEL DEANDRE FORD began shooting at Officers at the front entrance of the District III Station and then he took cover behind a Police Van that was parked in front of the Station on Barlowe Road.

During the shooting, responding officers asked MALIK RUSSEL FORD and ELIJAH DEION FORD where the shooter (MICHAEL DEANDRE FORD) was and MALIK RUSSEL FORD shouted he did not know, even though MICHAEL DEANDRE FORD is clearly visible on the video hiding behind the Police Van. By failing to disclose his location to the police MALIK RUSSEL FORD AND ELIJAH DEION FORD continued to assist MICHAEL DEANDRE FORD in the planned attack on the police enabling him to continue shooting at the police.



MALIK RUSSEL FORD then moved their red Honda and parked on Barlowe Road so he and ELIJAH DEION FORD could maintain visual sight of their brother, MICHEAL DEANDRE FORD and so their car was facing the direction they planned to flee. MALIK RUSSEL FORD and ELIJAH DEION FORD fled seconds after MICHAEL DEANDRE FORD was shot.

MICHAEL DEANDRE FORD intentionally shot at police officers and civilians with the intent of killing and to provoke gunfire in return. MICHAEL DEANDRE FORD acted with a wanton and willful disregard for human life. Officer Jacai Colson was killed as a direct result of the actions set in motion by MICHAEL DEANDRE FORD and the assistance and aid provided by MALIK RUSSELL FORD and ELIJAH DEION FORD. MALIK RUSSEL FORD and ELIJAH DEION FORD conspired with MICHAEL DEANDRE FORD to engage in a shoot-out with the police and provided assistance to him.

All of the aforementioned evens occurred in Prince George's County, Maryland.
