BEFORE ME, THE UNDERSIGNED MAGISTRATE, PERSONALLY APPEARED THE AFFIANT HEREIN, A PEACE OFFICER UNDER THE LAWS OF TEXAS, WHO BEING DULY SWORN, ON OATH MADE THE FOLLOWING STATEMENTS AND ACCUSATIONS:

My name is T.L. Bell, and I am commissioned as a peace officer by the Richland Hills Police Department in Tarrant County, Texas. I hereby state upon my oath that I have reason to believe and do believe that heretofore, and before the making and filing of this Complaint, that Moises Eli Castellon W/M 12/15/1987, on or about the 31<sup>st</sup> day of December, 2011, in Tarrant County, Texas, did then and there commit the offense of Sexual Assault in that he did intentionally or knowingly cause the sexual organ of [REDACTED], a child younger than 17 years of age, to enter the mouth of said defendant.

MY PROBABLE CAUSE FOR SAID BELIEF AND ACCUSATION IS AS FOLLOWS:

I, T.L. Bell #176, am assigned to the Criminal Investigation Unit of the Richland Hills Police Department in Tarrant County, Texas. I have been a peace officer for 17 years, and have been assigned to numerous criminal investigations.

1. On April 3, 2012 at about 1010 hours, Richland Hills Patrol Officer E. Pina was dispatched to the Cooks Children's Hospital located at 634 Martin Rd in Hurst, Texas on the report of a sexual assault. A report was later created and is it permanently recorded as Richland Hills Incident 1200004511.
2. Upon arrival, Officer Pina met with [REDACTED], who is the mother of [REDACTED], a 15 year old male. [REDACTED] reported [REDACTED] told her that on December 31, 2011 he met a male subject in the Richland Middle School parking lot located at 7400 Hovenkamp Ave. in Richland Hills, Tarrant County Texas. During this time, [REDACTED] told [REDACTED] that a male subject claiming to be 17 years old preformed oral sex on him. [REDACTED] reported she believes the male subject is older than 17.
3. On April 25, 2012, Investigator Perkins and affiant met with [REDACTED] [REDACTED] stated on 12-31-2011 he met "Junior" on chat group chatavenue.com teen chat. [REDACTED] said he made contact with "Junior" by telephone using number 817-[REDACTED] [REDACTED] told Investigator Bell that "Junior" told [REDACTED] he wanted to suck his cock. A meeting was set up for that evening (December 31, 2011). [REDACTED] said he met "Junior" at the Richland Middle School. [REDACTED] said he got into "Junior's" black Toyota Corolla and Junior gave him a blow job. Affiant called 817-[REDACTED] while on speaker. [REDACTED] said that the voice that answered was the voice he recognized as Junior.
4. [REDACTED] reported he continued communicating with Junior. On about January 17, 2012, another meeting between [REDACTED] and Junior was set up at the Richland Middle School. [REDACTED] said his mother dropped him off as he said he wanted to exercise. [REDACTED] said as he was approaching Junior's car, his mother drove back to the school. Junior sped away as soon as he got the text from [REDACTED] that his mother was at the school. [REDACTED] mother sent a text to Junior advising she made a police report RHPD #12-0766. [REDACTED] said he had no more contact with Junior after that.
5. On April 25, 2012, affiant called the number provided for Junior ([REDACTED]). A male subject answered the phone and identified himself as Moises Castellon W/M 12/15/1987. Moises Castellon denied any knowledge of knowing [REDACTED] denied going by the name of Junior and denied having a black Toyota Corolla.
6. Upon researching Moises Castellon, he was found to have Texas Driver's license 24296070 identifying him as Moises Eli Castellon. The address shows 3009 Primrose Ave in Fort Worth, Texas. Investigator Perkins searched Moises Castellon on Facebook and found a possible match that shows work information as Fort Worth ISD.
7. On April 26, 2012, Investigator Perkins drove to 3009 Primrose Ave in Fort Worth, Texas. Investigator Perkins saw a black 1999 Toyota Corolla bearing TX LP TDD978. This vehicle registers to a Moises O Castellon at this address.

- 8. On April 26, 2012, Investigators Perkins and Robinson responded to Fort Worth ISD Administration building located at 2901 Shotts St. in Fort Worth. There they met with Investigator [redacted] who confirmed Moises Castellon is a current employee. [redacted] provided a current photograph of Moises Castellon from his work ID.
- 9. On April 27, 2012, Officer Spears and affiant presented a photo spread to [redacted] using the photograph from Fort Worth ISD of Moises Castellon. [redacted] positively identified Moises Castellon as the person who performed oral sex on him.

Moises Castellon is described as being a white male, date of birth of 12/15/1987. He is about 5'4 in height and about 100 pounds in weight. Moises Castellon has brown eyes and brown hair. Moises Castellon's Texas DL number is 24296070, which expires in 2012 and shows the address of 3009 Primerose Ave in Fort Worth, Texas 76111.

ALL FACTS CONTAINED in this affidavit are true and correct to the best of the affiant's knowledge.

THEREFORE, I REQUEST that an arrest warrant be issued for the suspect hereinbefore designated according to the laws of the State of Texas.
